1/ Approval of Previous Minutes

The Minutes of the PVOA Meeting held on Thursday 8th September were approved.

3/ Conveyancing of Parking Spaces and Common Land, Powderhall Village Owners Ltd.

The draft Disposition has been agreed and is with Taylor Wimpey. Jane Ramsay of MBM (Commercial) has notified Roddy that Shepherd & Wedderburn is waiting to hear from its client (Taylor Wimpey) on a procedural point before issuing the deed for signing.

Once the Taylor Wimpey Conveyancing has been completed, Frans suggested that large purpose-built Private Parking signs be placed at the three entrances to Powderhall Village. Gordon has drawn up a Parking Policy document for consideration.

There is still abuse surrounding the issue of Owner and Visitor Parking Permits. On a recent count, only 11 out of 27 cars parked on Powderhall Road were displaying permits. Adam suggested that when permits are re-issued in March, Owner and Visitor passes be in different colours.

C/ Waste Collection

Discussions over changing Council Waste Collection Times in hand with Robert Brown, the Council's Waste Manager..

There is an on-going problem and spilled rubbish following collections is causing increased irritation, not least because of the health risk. Stuart had recently photographed an incident for posting on Facebook and had cleaned up the mess himself. It would be helpful if any further incidents such as this can be photographed and put on the Facebook Page which, we hope will be seen by Council Officials.

It was also suggested that any Resident with a Twitter Account should make use of it to

keep Edinburgh Council informed as to their annoyance.

It was emphasised that it is NOT the responsibility of Charles White to take up waste problems with Edinburgh Council although Sarah will obviously try to be as supportive and helpful as possible. Residents must make contact with the Council directly to complain. Kevin, who was unfortunately unable to attend this meeting, has already made a useful engagement with Robert Brown, Waste Manager and Ronnie Young, Supervisor. It is well known that the Council is having waste collection problems across Edinburgh.

The Powderhall Village Landscape Contractor is supposed to pick up stray litter, but this depends upon when their operatives are on-site.

In certain Bin Stores, residents consistently fail to break up large boxes on the assumption that they will be taken away regardless. This does not happen. Large cardboard boxes MUST be broken up and inserted into the Packaging Container or, as with other large household objects, transported independently to the Refuse Depot at Seafield.

Discussion as to how to improve access to Bin Stores at the Rigg is ongoing.

Bin Store Doors

There is an issue with bin store doors being constantly battered by waste collectors and left open. Sarah has been on site with a contractor to discuss the addition of an extra spring and extra piece of wood to ensure that they close correctly.

Residents are asked to be mindful of switching off store light. It is proposed that all Bin Store lights are eventually changed over to motion sensitive as and when they go on and off.

D/ St Mark's Park Bridge

Councillor Nick Gardner has forwarded a report from the CEC'S Bridges team:

"I have inspected the top section of the aforementioned bridge and it is in a perfectly fit condition. The timber is Greenheart and not Yellowheart, as previously thought, and this wood is a hard and robust wood that is used for this kind of construction. There are a few what looks like shakes but that is perfectly normal (runs with the grain) for this type of wood. Also there are normally no requirements yo treat this type of timber."

Councillor Gardner added that if any works were being proposed for this (or any bridge within CEC bridge stock), permission would have to be obtained as the Council has to approve materials etc to maintain the longevity and maintenance of the bridge.

E/ Flower bed on Beaverhall Road

A flower bed belonging to Powderhall Village on Beaverhall Road has been damaged during the Powderhall Gate building operations. Sarah has contacted Springfield Developments and this is to be rectified.

F/ Dog Fouling and Health Issue for Children

The installation of Notices has proved relatively successful and the majority of dog walkers appear to be obeying the instructions. However, there have been complaints as to the manner in which some dog owners have been approached in this regard and the PVOA is anxious to emphasise that at all times anyone seen possibly to be offending, should be approached with tact and politeness.

G/ Wildlife Meadow Planting

Following a meeting initiated by Richard to initiate the creation of a Wildflower Meadow at the centre of Powderhall Village, Stephen MacGregor of Edinburgh Living Landscape has informed him that there is too much work going on at the moment so this will not be progressed at this time.

I/ Canonmills Garden (B&Q Development)

It was learned that the trees dividing the B&Q site from Powderhall Brae are to be removed and Mel and Karen have organised and submitted a petition on behalf of the Brae owners and have applied for a Tree Protection Order. However, some Brae owners are anxious about the on-going problem of excessive tree growth threatening their properties and should the trees be retained, it must be made clear to the developer (or subsequent owners) that they are responsible for cutting back the branches on a regular basis.
